 4. Women's Masters Figure - women who have reached 35 and 45 years of age by date of show. (All competitors must be 18 years or older on the day of the contest. Masters must show proof of age, i.e., driver's license, birth certificate).
 5. All Fitness and Figure competitors must be 18 years or older on the day of the contest.
- NOTE: Each contestant may enter more than one division at a cost of \$70 per division. Athletes may change divisions at the check-in, but changes must be made before the prejudging starts.
- ABSOLUTELY NO ALCOHOLIC BEVERAGES** of any kind will be allowed on the theater property. Any contestant found violating the above rules will be immediately disqualified.
