  2. Novices who have not won any OVERALL TITLE (except Teenage).
  3. Men's Masters, over 40, 50 and over 60. Master's Figure over 35 and over 45.
  4. Teenage Men must not have reached their 20th birthday on the day of the show.  
(All competitors must be 18 years or older on the day of the contest. Masters must show proof of age, i.e., driver's license, birth certificate).
  5. All Figure/Fitness competitors must be 18 years of age or older on day of contest.
- NOTE: Each contestant may enter more than one division at a cost of \$70 per division. Athletes may change divisions at the check-in, but changes must be made before the prejudging starts.
