- ELIGIBILITY:** This competition is open to all NPC registered athletes who meet the following requirements:
1. Possess a current NPC card (unregistered athletes may purchase cards for \$80.00, which is valid thru December 31, 2008). NPC cards available at check-in.
 2. Novice Bodybuilders who have not won any OVERALL TITLE (except Teenage).
 3. Men's Masters, over 40, 50 or 60. Master's Figure, over 35 and over 45.
 4. Teenage Men must not have reached their 20th birthday on the day of the show. (All competitors must be 18 years or older on the day of the contest. Masters must show proof of age, i.e., driver's license, birth certificate).
 5. All Figure competitors must be over 18 years years old on the day of the contest.
- NOTE: Each contestant may enter more than one division at a cost of \$70 per division. Athletes may change divisions at the check-in, but changes must be made before the prejudging starts.
- ABSOLUTELY NO ALCOHOLIC BEVERAGES** of any kind will be allowed on the theater property. Any contestant found violating the above rules will be immediately disqualified.

1. Have you taken any anabolic steroids since August 16, 2007. **Note: Over the counter sports enhancement products are acceptable.**

Note: It is the responsibility of each athlete to make an appointment for the polygraph examination. If you do not make it to your examination on the date and time scheduled, you will be rescheduled only if the examiner schedule permits. The event promoters are not responsible for making appointments or for payment of any fees to the examining center.

The above testing center is the only authorized polygraph center. Polygraph results from any other center will not be accepted.
