CHECK-INS & WEIGH-INS:

Athlete briefing at 8:00 AM. Check-ins/Weigh-Ins start at 8:30 AM. Another Athlete briefing will be at 5:30 PM.

ELIGIBILITY:

This competition is open to all NPC registered athletes who meet the following requirements:

1. Possess a current NPC card (unregistered athletes may purchase cards for \$85.00, which is valid thru December 31, 2009). NPC cards available at check-in.
2. Novice Bodybuilders who have not won any OVERALL TITLE.
3. Men's Masters, men who have reached 40, 50 and 60 years of age by date of show.
4. Women's Masters Figure/Bikini - women who have reached 35 and 45 years of age by date of show. (All competitors must be 18 years or older on the day of the contest. Masters must show proof of age, i.e., driver's license, birth certificate).
5. All Figure/Fitness/Bikini competitors must be over 18 years old on the day of the contest.
6. No cross-overs between figure division and bikini division are allowed. Cross-overs are allowed within each category.

NOTE: Each contestant may enter more than one division at a cost of \$70 per division. Athletes may change divisions at the check-in, but changes must be made before the prejudging starts.

ABSOLUTELY NO ALCOHOLIC BEVERAGES of any kind will be allowed on the theater property. Any contestant found violating the above rules will be immediately disqualified.
