There will be no check-ins for Figure or Bikini contestants on day of contest. Check-ins for NPC Men & Women's Bodybuilding will be held at Veteran's Memorial Auditorium on Saturday at 8 am.
- ELIGIBILITY:** This competition is open to all NPC registered athletes who meet the following requirements:
1. Possess a current NPC card (unregistered athletes may purchase cards for \$90.00, which is valid thru December 31, 2010). NPC cards available at check-in.
 2. Men's Masters, over 40 and over 50. Master's Figure over 35 and over 45.
 3. Teenage Men must not have reached their 20th birthday on the day of the show. (Masters & Teens must show proof of age, i.e., driver's license, birth certificate).
 4. All Figure & Bikini competitors must be 18 years of age or older on day of contest.
 5. No cross-overs between figure division and bikini division are allowed. Cross-overs are allowed within each category.
- NOTE: Each contestant may enter more than one division at a cost of \$80 per division. Athletes may change divisions at the check-in, but changes must be made before the prejudging starts.
- Please be on time! All Bodybuilding competitors will perform 60 second posing routine at the evening finals.
